- A. Local Economic Revitalization Tax Assistance (LERTA) – This item will be continued.
- B. Act 172 - tax credit on real estate or earned income for active volunteer firefighters and nonprofit emergency medical service members. Mr. Schaible will present, at a future Finance & Administration Committee Meeting, the criteria to provide a tax incentive for volunteer fire companies.
 - Commissioner Spearing asked if residents who already pay a tax credit in another municipality can apply the tax credit back to the Township. Mr. Schaible will provide further clarity on this issue at a future Finance & Administration Committee Meeting.

IX. **New Business:**

- A. Proposed Reforms to the Decennial Legislative and Congressional Redistricting Process in the Commonwealth of Pennsylvania
 - Commissioner Lockard read a petition for the Committee to consider a resolution by the Board of Commissioners that declares the Township's support of Pennsylvania State Legislation to amend the Constitution of the Commonwealth of Pennsylvania and provide a fair redistricting process.
 - Commissioner Spearing commented on the definition of a census block for redefining the voting districts. Ms. Prior, Township Solicitor, will provide a follow up on the census block.
 - Brian Shannon, a resident, commented on redistricting and defining the census block.
