Re: 2010 Men's Fall Softball Season

-Listed below are the preliminary details for the 2010 season-

1. **Number of teams** – the league will accept a maximum of 10 teams for the fall season (new teams will be admitted as space allows).
2. **Residency requirements** – a Resident team is defined as a team with 50% of its players living in Upper Moreland Township or a team that has a sponsor based in Upper Moreland Township. Anything else will be considered a Non-Resident team.
3. **Team fees** – these fees include: field maintenance, ASA team registration, equipment fees, park attendants, administrative fees, league supervisor, officials fees for the playoff finals, all mailings and a \$68 forfeit fee (returnable if you do not forfeit any games).  
**Resident Team Fee: \$450.00 Non-Resident Team Fee: \$625.00**  
Team fees may be made payable to "Upper Moreland Township". Final payment is due on Friday, July 30<sup>th</sup>. Officials fees are not included in this registration fee.
4. **Officials fees** – each team is required to pay the official \$17.00 in cash, at each game, prior to the start of the game. For 2010, teams can expect to play a 9 game season, x \$17/game for a total of \$153.00. Teams must pay the official fees for Rounds One & Two of the playoffs; the department pays the officials for the finals.
5. **Adult League Request Form** – (yellow) must be filled out entirely and returned by Friday, July 10, along with the appropriate team fee. **If form and fee is not received, team space may be forfeited to new team(s) interested in gaining admittance to league.**
6. **Games** – are played at North Willow Grove, Terwood, and Masons Mill Park. The season begins on Monday, August 23 and each team will play a 9 game schedule. Games are played on **Monday** and **Wednesday** evenings as per the schedule at 6:30PM, 7:45PM and 9:00PM. Make-Ups will be planned as listed on the league schedule **OR on the first available Sunday following a cancellation** as determined by the Parks and Recreation Department. The season will conclude by October 27 (including playoffs). Games may be cancelled due to weather and not rescheduled pending availability.
7. **Rosters** – (blue) are due prior to the first game of the season to the Parks and Recreation office or at Masons Mill Park. The rosters must have all the team members' signatures or it will be rejected. Changes to the roster may be made throughout the entire season.
8. **Coach's organizational meeting** – is scheduled for **Wednesday, August 4** at 7:00PM, at the Township Building. One team representative must be in attendance at the meeting or team requests will NOT be honored. You will receive your key to the equipment boxes at Terwood and NWG and a game ball to use for practice or as a backup ball in your first game.
