- I. **Call to Order:** Matthew H. Candland, Township Manager, called the meeting to order via Zoom at 7:00 p.m.

- III. **Approval of Meeting Minutes - April 8, 2021:**
 - Dr. Roesser amended the minutes under Section IV, B., sixth arrow, "...include a grading system of goals, which are measurable, specific and attainable.
 - ***Ms. Hill motioned, seconded by Dr. Worth-LaManna and the Commission voted 4-0 to approve the minutes, as amended.***
