3. Return must be filed on a calendar-year basis. Number of days in Township includes any part of a day and must be counted as a full day.
4. This Return is only to be used by a business which is “temporary, seasonal or itinerant in its nature” in accordance with Section 310-10(C) of the Township Code and not for any other business that has a Business Privilege Registration or Mercantile License with the Business Tax Office.
5. **LATE FILING:** Penalty of 10% of tax, plus interest at a rate of 1 ¼% per month (or fraction thereof) if filed after due date.
6. **EXCLUSIONS:** YOU MUST ATTACH A WRITTEN REQUEST. Examples would be canceled contracts, job time sheets, etc.
